Frequently Asked Questions

Please note that this document has been updated following the provisional selection of BEAD awardees. New questions are denoted in red, and a summary of questions added to this FAQ are summarized in the table on page 23.

1. GENERAL INFORMATION

1.1. What is BEAD?

Response: The [Broadband Equity, Access, and Deployment \(BEAD\) program](#) provides \$42.45 billion to expand high-speed internet access by funding planning, infrastructure deployment, and adoption programs. Montana was allocated a \$629 million grant under the BEAD Program to improve broadband coverage across the state. BEAD Program requirements focus this funding on unserved, locations unable to obtain broadband service of at least 25 Megabits per second (Mbps) downstream and three (3) Mbps (25/3 Mbps), and underserved locations, those locations with broadband service between 25/3 Mbps and 100/20 Mbps, and 1 Gbps symmetric for community anchor institutions (CAIs).

1.2. What are the requirements for the State to receive BEAD funding?

Response: To receive the \$629 million in BEAD funding, the State must comply with the NTIA requirements. The Montana Broadband Office (ConnectMT) has completed all prior and updated requirements to date. As required by NTIA, ConnectMT conducted a subgrantee selection process and submitted a [final proposal](#) to NTIA on September 3, 2025, and was approved by NIST on December 9, 2025.

1.3. What unserved and underserved areas were prioritized during the BEAD application process?

Response: The State complied with the NTIA BEAD [Notice of Funding Opportunity \(NOFO\)](#) requirements when selecting projects. Under NTIA guidelines, the State must award projects to provide coverage of all unserved locations followed by all underserved locations and if funding allows eligible community anchor institutions. The [Initial Proposal Volume 2](#) and the [BEAD Restructuring Policy Notice](#) outline the process the state used to select subgrantees.

1.4. Who was eligible to receive BEAD funding from the ConnectMT Broadband Office?

Response: Consistent with SB 531, an eligible applicant means an entity that has authorization to do business in the state and has demonstrated that it has the technical, financial, and managerial resources and experience to provide broadband services or other communication services to customers in the state. This includes incorporated businesses or partnerships, Montana nonprofit organizations, limited liability companies, corporations, or cooperative entities organized for the purpose of expanding broadband access. A government entity or tribe is only eligible to apply in partnership with an eligible broadband service provider.

To be eligible to receive BEAD funding from the State of Montana, subgrantees must:

1. Meet mandated financial, operational, and managerial requirements
2. Propose a project that will provide a minimum 100/20 Mbps broadband service to all locations within the service area within a 4-year timeline
3. Be able to comply with all requirements mandated by the NTIA and the State of Montana

1.5. What is the matching requirement for the BEAD Program? Do waivers exist for this matching requirement, and in what circumstances would those waivers be provided?

Response: As noted in the BEAD NOFO, except for specific circumstances where NTIA has waived the matching requirement, subgrantees were required to provide a match of 25% of subaward amount. NTIA removed the match requirement for the NTIA defined High Cost CBGs. Please note, this is only for the 23 CBGs designated as high cost by NTIA. (A list of high-cost areas by census block group can be found on the ConnectMT IJA/BEAD Resources page under NTIA BEAD Program.) With regards to match waivers, NTIA granted all relevant waivers for high-cost area projects in Montana.

1.6. Will ConnectMT record and/or post BEAD Technical Assistance Webinars?

2. SUBGRANTEE SELECTION PROCESS

2.1. What was the Montana BEAD Challenge Process?

Response: During the initial Map Challenge Process, eligible challengers such as nonprofits, internet service providers (ISPs), and local and tribal governments were invited to submit challenges to the National Broadband Map to help ConnectMT finalize the list of BSLs and CAIs eligible for BEAD funding. Through a transparent, evidence-based, and fair review of submitted evidence, ConnectMT determined if challenges were sustained or rejected to finalize the list of unserved, underserved, and served locations for the BEAD Program. As required by the [BEAD Restructuring Notice](#) in June 2025, ConnectMT also held an Unlicensed Fixed Wireless (ULFW) Challenge Process.

2.2. How was the Prequalification Application Round conducted for the BEAD Program?

Response: In accordance with the [Initial Proposal Volume 2](#), ConnectMT launched this phase in March 2024. The prequalification phase of the subgrantee selection process was used to determine whether applicants met the BEAD minimum eligibility requirements, including financial capability, organizational capability, certifications, and compliance. ConnectMT

received 26 prequalification applications; 22 were determined to be eligible, and 4 were found to be ineligible.

Following the issuance of NTIA's [BEAD Restructuring Policy Notice](#), ConnectMT reopened the prequalification process during the Benefit of the Bargain Round in June 2025. The following were invited to participate in the reopened prequalification process: new entrants seeking to participate in the BEAD Program (regardless of technology), and existing applicants who had previously failed prequalification and chose to update their materials to seek prequalification again. Previously approved prequalified applicants were not required to reapply. ConnectMT reviewed newly submitted prequalification applications in accordance with the new guidance provided by NTIA in the BEAD Restructuring Policy Notice. ConnectMT received 6 new prequalification applications; 4 were determined to be eligible, and 2 were found to be ineligible.

2.3. How many application rounds did Montana conduct, and how were BEAD applications reviewed?

Response: Montana conducted two application rounds following the pre-qualification phase. In October 2024, ConnectMT launched the Main Round BEAD application round for both Priority and Non-Priority applications. ConnectMT received a total of 42 applications and initiated its application review and negotiation process as outlined in [Initial Proposal Volume 2](#). Pending new guidance from NTIA and the Trump Administration, ConnectMT paused all other program activities.

On June 6, 2025, the [NTIA BEAD Restructuring Policy Notice](#) was released, requiring ConnectMT to conduct a Benefit of the Bargain Round, in which ConnectMT would evaluate or reevaluate applications for every BEAD-eligible location, regardless of technology. Any applicants who had previously submitted a successful prequalification application were able to apply to the Benefit of the Bargain Round. Applicants who had previously submitted project applications in the Main Round could choose to either update and resubmit their existing application or submit a new application. The Benefit of the Bargain Round closed in July 2025.

2.4. Which project and awardee requirements were altered and/or removed due to the NTIA Restructuring Policy Notice (RPN)? Where can I find details about the affected requirements?

Response: The [Restructuring Policy Notice](#) released by NTIA on June 6, 2026, made the following changes to BEAD Program requirements:

- **Definition of Priority Projects:** The term Priority Broadband Project is defined as a project that meets certain upload, download and latency requirements, regardless of technology type.
- **Labor, Employment, and Workforce Development:** Non-statutory requirements related to labor, employment, and workforce development in the BEAD NOFO are no longer required.

- **Climate Change:** Requirements related to climate change, specifically the Climate Resilience section of the BEAD NOFO, are no longer required.
- **Open Access/Net Neutrality:** Requirements related to open access and net neutrality stated in the NOFO are no longer required, specifically ensuring that data usage caps on any plans offered are not imposed on consumers.
- **Local Coordination and Stakeholder Engagement:** Awardees are no longer required to consult with representatives of various demographics and identity-based groups.
- **Non-Traditional Broadband Providers:** Traditional and non-traditional Broadband providers, such as municipalities or political subdivisions, are evaluated and considered equally.
- **Middle Class Affordability Plan:** Awardees are no longer required to develop a middle-class affordability plan.
- **Low-Cost Service Option:** Non-statutory requirements in the BEAD NOFO related to low-cost broadband service options are eliminated, specifically the Affordability and Low-Cost Plans. Note that awardees are still required to provide at least one Low-Cost Service Option and can set the price for this service.

2.5. Were BEAD applications re-scored with the new criteria from the updated NTIA policy guidance?

Response: Yes, following the Restructuring Policy Notice, Montana updated its scoring criteria to focus on cost minimization, and applications received a new score. See the approved scoring rubric on the ConnectMT page [Internet Service Provider Information](#) for updated criteria.

2.6. Will the BEAD application summaries be posted after the application window closes?

Response: Montana included application summaries as part of the [Final Proposal](#), which was submitted and posted in September 2025 and approved by NIST in December 2025. The proposal outlines the projects provisionally selected for funding.

2.7. When will subgrantee awards be determined?

Response: ConnectMT is working diligently to continue the progress of the BEAD Program. Montana's Final Proposal was submitted in September of 2025 to NTIA and approved by NIST in December 2025. ConnectMT

2.8. Did the same companies receive funding as ARPA?

Response: ConnectMT performed a subgrantee selection process consistent with SB 531, the Initial Proposal, and subsequent NTIA guidance. Companies that received ARPA funding may choose to apply for additional projects through the BEAD application process.

2.9. If a competing application was selected over mine, am I able to know the details that went into that decision?

3. ELIGIBLE LOCATIONS AND MAPPING

3.1. What is the Montana Broadband Availability Map?

Response: The Broadband Availability Map is the outcome of Montana's BEAD Challenge process, identifying which locations within Census Block Groups (CBGs) are eligible for funding under the BEAD Program. It can be found at <https://ConnectMT.mt.gov/ConnectMT/ijja/>. Each CBG outlines the number of served, unserved, and underserved locations, the total number of locations, the benchmarking reference price, and the percentage of the CBG eligible for BEAD funding. With the issuance of the BEAD Restructuring Policy Notice, it was updated as of July 16, 2025.

3.2. How do I show only BEAD-eligible locations?

Response: To view BEAD-eligible location data only, remove all layers on the map. Go to the IJJA Map page. Select the State Broadband Availability Map drop-down. Select the State Broadband Availability Map. On the map home page, at the top right of your screen, you will see three icons. Select the middle icon (layer list). Please unselect the five FCC USAC locations: the FCC Rural Digital Opportunity Fund, the FCC Enhanced Alternative Connect America Cost Model, The USDA ReConnect Loan and Grant Program, and the US Treasury American Rescue Plan by clicking the blue check marks. Once all these layers are removed, the resulting map view will show BEAD-eligible locations.

3.3. How do I learn more about the Montana Broadband Availability Map functionality?

Response: Refer to the State of [Montana BEAD Broadband Map How-to Guide](#) for step-by-step instructions. This guide outlines the purpose of each map, outlines how to access the map, and provides detailed instructions on using features and functionalities.

3.4. Has the ConnectMT Broadband Office published a location eligibility list?

Response: Yes, the current Locations List spreadsheet includes the official list approved by NTIA on June 30, 2025. Applicants can find the [template](#) on the ConnectMT website under Internet Service Provider Information and Benefit of the Bargain Application Materials.

3.5. What version of the fabric data was used during the Benefit of the Bargain round?

Response: Fabric Version 3.2 was used as the foundational dataset and ConnectMT modified it to incorporate updates from Fabric Version 6, which allowed for the removal of locations no longer eligible for BEAD funding.

3.6. My house is listed as an eligible location to receive service. Who will be providing the service, and what kind of technology will it be?

Response: As outlined by NTIA, all eligible locations will receive service under the BEAD Program. Once NTIA has approved Montana's Final Proposal and ConnectMT has fully executed its award agreements, interested parties may refer to the Montana Broadband Availability Map. The map will be updated to reflect the provider and technology type to serve each eligible location.

3.7. If my house is indicated as served by Satellite Internet service, what does this mean for me?

Response: Satellite internet service providers are still subject to the same upload, download, and latency speed requirements for all BEAD projects as set by NTIA. More guidance regarding low-earth orbit (LEO) Internet and how it will be accessed is forthcoming.

3.8. How should subgrantees address changes to project locations after award execution?

Response: Please contact ConnectMT with any questions regarding any changes to project locations.

4. PROGRAMMATIC REQUIREMENTS

4.1. What process did awardees follow if their project locations intersect with Tribal Lands?

Response: Applicants that submitted applications for project areas that are partially or wholly located on Tribal Lands must secure written permission from the Tribe or Tribes that own the land. The applicant must submit a Resolution of Consent or other formal demonstration of consent from each Tribal Government, either from the Tribal Council or other governing body, upon whose Tribal Lands the infrastructure will be deployed. Sub-awardees must provide a Resolution of Consent within six months of the approval of the BEAD Final Proposal.

4.3. Can you provide guidance on what the Parent Guarantee is that is being asked of in the BEAD Grant Agreement?

Response: Yes, the purpose of the parent guarantee is to ensure that the approved BEAD project is completed, including the connection of all BSLs. Therefore, the parent and the BEAD awardee must enter into a legal agreement that, at a minimum, guarantees that the Parent will complete the BEAD project, including the connection of all approved BSLs.

4.4. What is the deadline for providing Tribal Consent, if required?

Response: ConnectMT will require Tribal Consent with the execution of your organization's Grant Agreement. NTIA requires Tribal Consent to be submitted in order for ConnectMT to release funds.

4.5. Are subgrantees able to submit audited financial statements at the parent-company level?

Response: Yes, audited financial statements of a parent company may be sufficient to meet the BEAD Program's audit requirements if the statements meet all relevant requirements in the BEAD NOFO, 2 CFR Part 200, and the BEAD General Terms and Conditions.

4.6. NTIA updated the BEAD Letter of Credit to clarify that providers will have within 60 days of signing their Grant Agreements to fulfill this obligation. Is that time extension applicable to both the letter of credit and performance bond, or just the latter?

Response: Per Question 8.5 of the most recent [NTIA FAQ](#), the time extension is only applicable to the performance bond.

4.7. For the bond or ILOC, are there any options to reduce the bond or ILOC amount dependent on the completion portion of the project?

Response: ConnectMT has chosen not to execute option 2.3 ("Reduction of LOC/Performance Bonds Upon Completion of Milestones") of the [Letter of Credit waiver](#), and therefore, there is no option to reduce the bond or ILOC amount.

4.8. We are mobilizing materials for the market. The materials are pledged to match, from our inventory and are confirmed as BABA compliant. Are these acceptable to use, or must everything be produced after Grant Agreement execution?

Response: Under NTIA's [Build America, Buy America \(BABA\) requirements](#), materials are not required to be procured after Grant Agreement execution. Compliance is based on whether the

materials meet the applicable domestic production standards at the time they are incorporated into the project. Pre-existing inventory that is confirmed to be BABA-compliant and supported by manufacturer certifications is acceptable for use.

4.9. Are subgrantees required to obtain competitive bids for subcontractors if a project partner was proposed and approved in their BEAD application?

Response: Subgrantees must comply with the federal procurement standards outlined in 2 CFR §§200.317–200.320. If a subgrantee proposed a partner in their BEAD application that has already been approved, ConnectMT will not require a new competitive bidding process.

4.10. In the Grant Agreement, compliance with state laws is addressed. Does the MT Prevailing Wage law apply?

Response: The MT prevailing wage law does not apply.

4.11. What is the required amount for the Irrevocable Letter of Credit (ILOC) under the BEAD grant? Is the amount based on a percentage of the award or a fixed value?

Response: The initial Irrevocable Letter of Credit (ILOC) must be issued in an amount equal to 25% of the total subaward.

4.12. How do Build America, Buy America requirements apply to existing infrastructure, that was constructed 10-20 years ago, used as in-kind match (e.g., towers, fiber, or conduit constructed prior to the BEAD Program)? Do these requirements apply retroactively to legacy facilities?

Response: Under 2 C.F.R. § 200.306, in-kind contributions used to meet cost-sharing or match requirements are considered part of the total approved federal project budget and must comply with all applicable program requirements, including Buy America (BABA) domestic sourcing provisions. Because legacy infrastructure (e.g., towers, fiber, or conduit) was not originally procured in accordance with BABA standards and no retroactive waiver has been issued, such assets are not eligible to be contributed as in-kind match for BEAD, regardless of remaining useful life.

5. REPORTING REQUIREMENTS AND DISBURSEMENTS

5.1. What can awardees expect the Disbursement Process to be for the Monitoring and Compliance phase of the BEAD Program?

Response: A milestone disbursement process will be implemented, disbursing funds to each subgrantee only after the successful and verified completion of each predefined project milestone. Disbursement requests must be submitted through the Euna Grants (formerly known as AmpliFund) portal.

Each subgrantee will have a milestone-based budget and disbursement schedule specific to their project. For further details regarding the Disbursement Process' timeline, project phasing,

and examples, see your project's respective Grant Agreement and the draft [Disbursement Process Guide here](#).

5.2. What are the performance monitoring and reporting requirements for the BEAD Program?

Response: In September 2025, NTIA released the [BEAD Policy Notice: Performance Measures for the BEAD Last-Mile Networks](#). The policy notice outlines what subgrantees must test with regards to network speed, latency, and availability, how the tests are to be completed, and the frequency of testing required.

- **Speed:** NTIA requires that 80% of download and upload measurements be at or above 80% of the required speed tier. Upload and download tests are counted separately.
- **Latency:** 95% of the measurements must be at or below 100 milliseconds.
- **Network Availability:** the provider must show an average outage across its locations below 48 hours per calendar year.

Subgrantees must test a random sample size of active subscribers for each speed tier and technology type. The number of test locations is based on the FCC BDC map and determined by the number of active subscribers. Testing will begin during the BEAD Program period of performance and be conducted annually at a minimum.

A provider is considered non-compliant if it fails to meet any of the 4 thresholds: download, upload, latency, or availability criteria. A provider is also considered non-compliant if it fails to use compliant testing methodology, fails to report measurement results on time, or fails to comply with transparency requirements in accordance with the NOFO and terms and conditions of an award.

5.3. What is the maximum pre-award costs allowed before grant execution?

Response: Pre-award costs cannot exceed 5% of the requested funding amount.

5.4. What specific costs qualify as pre-award costs for BEAD?

Response: ConnectMT allows certain pre-award costs as outlined in our Benefit of the Bargain User Guide. Pre-award costs are costs incurred after the publication of the BEAD NOFO but before the Grant Agreement is executed and include activities such as application development and design engineering (stage 1). Construction activities (ex., purchasing of inventory) completed before award approval are not eligible as pre-award costs.

5.5. What are the monitoring activities that my organization can expect from ConnectMT?

Response: Subgrantees should expect regular monitoring activities, including quarterly and annual reports, quarterly update calls, and milestone reviews. ConnectMT may also conduct

desk reviews, field inspections, and project site visits if issues arise, such as project changes, compliance findings, unresolved issues, or audit results.

5.6. What is Euna Grants, and what will it be used for?

Response: Euna Grants (formerly known as AmpliFund) is the cloud-based platform where BEAD award documentation will be submitted for grants management. It will be used for quarterly and annual report submissions and disbursement requests. Awardees will be invited to the BEAD award in Euna Grants after their Grant Agreement has been signed and reviewed by ConnectMT.

5.7. When will subgrantees be required to submit the quarterly report?

Response: Subgrantees will submit quarterly project reports in Euna Grants on a recurring schedule. Quarterly reports are due January 7th, April 7th, July 7th, and October 7th each year during the reporting period.

5.8. Do LEO subgrantees have different quarterly reporting requirements?

Response: Yes, LEO subgrantees will submit LEO quarterly project reports beginning when their Grant Agreements are signed and continuing for ten years from the date that they certify broadband is available at every project location.

5.9. What is the ConnectMT BEAD Risk Assessment process?

Response: ConnectMT will use an initial risk assessment and ongoing risk monitoring to tailor monitoring intensity. Risk levels (low, medium, high) help determine the frequency and depth of monitoring. Subgrantees will complete an initial risk assessment questionnaire and annual risk questionnaires.

5.10. How does milestone-based disbursement work for BEAD?

Response: ConnectMT will administer BEAD funds through a fixed-amount, milestone-based disbursement process. Subgrantees will have a project-specific milestone-based budget and disbursement schedule and will submit disbursement requests in Euna Grants after completing each milestone. Subgrantees are encouraged to refer to their respective Grant Agreement, the Disbursement Process Guide and the BEAD Monitoring Guide for more information.

5.11. What types of documentation are required for milestone completion?

Response: Required documentation varies by milestone and project type and is used to verify milestone completion. Documentation may include project schedules, location lists,

environmental and permitting materials, design and route files, bills of materials, executed Grant Agreement, evidence of approvals, and, where applicable, performance testing and as-built documentation. Subgrantees should reference their Grant Agreement, milestone documentation matrix, and the [Disbursement Process Guide](#) for milestone-specific requirements.

5.12. How should organizations prepare for a ConnectMT desk review?

Response: ConnectMT will email organizations a checklist before a desk review. Organizations will compile requested documents and submit them via email and/or [Montana's Secure File Transfer Service](#) by the requested deadline. Desk reviews may include administrative, financial, procurement, and technical components.

5.13. What should organizations expect during a site visit or field inspection?

Response: ConnectMT may inspect project sites to validate milestone completion and confirm the accuracy/quality of deployed infrastructure compared to reported documentation.

5.14. Can milestones be completed in overlapping phases, or must all components of a given milestone be fully completed before beginning the next milestone phase?

Response: Yes. Often, work may overlap operationally, but disbursements are only released when each milestone's requirements are fully completed and documented. However, please note that certain activities cannot be initiated until the project has obtained EHP approval.

5.15. Will Subgrantees be required to identify specific Broadband Service Locations (BSLs) or subprojects to support milestone groupings (e.g., 20%, 40%, 60%) and demonstrate milestone completion?

Response: Yes. The project plan milestone framework allows providers to create subprojects that group specific BSLs and related infrastructure for the purpose of documenting milestone completion. Providers may define these subprojects based on their operational needs. Milestone disbursements are then tied to one or more subprojects meeting or exceeding the required percentage of total project BSLs (20%, 40%, 60%, 80%, and 100%) completed for Engineering and Permitting, Pre-deployment, Deployment, and Network Activation milestones.

5.16. How should Subgrantees document material procurement versus installation for milestone purposes?

Response: Keep procurement records—such as purchase orders, invoices, receiving documents, and inventory logs—separate from installation evidence, including as-builts tied to BSLs. Deployment milestones specifically require as-builts. The milestone evidence templates include dedicated fields that allow providers to record and document this information accurately.

5.17. Do the completed engineering drawings (milestones for initial 10% in 2% reimbursements) need to be certified by a Professional Engineer?

Response: No. The agreement requires “completed engineering drawings” for milestone credit but does not require Professional Engineer certification.

5.18. How should subgrantees document and verify match?

Response: Match must appear in the approved Project Budget, be properly valued and documented, and be auditable. This information will be required during quarterly reporting and each milestone disbursement request.

5.19. Has NTIA provided guidance on what will be required for internal reporting (items such as payroll, wage licenses, etc.)?

Response: NTIA does not require subgrantees to routinely submit internal administrative records (such as payroll files, wage licenses, or personnel records) as part of regular reporting. Instead, subgrantees are required to submit quarterly and annual project reports to ConnectMT through Euna Grants for the duration of the subgrant.

While these internal records are not submitted on a regular basis, subgrantees must maintain complete and accurate documentation supporting all reported project activities, expenditures, and compliance requirements. This includes, as applicable, payroll records, prevailing wage documentation, licenses, contracts, and other financial or administrative records.

These records must be retained in accordance with federal recordkeeping requirements and made available upon request to support ConnectMT monitoring and reporting activities:

- Quarterly and annual reporting
- Milestone-based disbursement requests
- Desk reviews, site visits, or other monitoring activities
- Audit or compliance reviews, if applicable

Subgrantees are responsible for certifying that all information submitted is accurate and for ensuring that supporting documentation is readily available throughout the period of performance and the required record retention period.

5.20. Please confirm the date by which the funds are eligible to be applied to match and/or meet milestones?

Response: Once the subgrantee has a fully executed Grant Agreement, they can submit the first project plan milestone request and documentation for approval and reimbursement.

5.21. Could you please clarify how the matching funds should be reported on the reimbursement request? In the ARPA reimbursement, the amount reimbursed was the total cost minus the match. How will this be handled in this case? Will the reimbursement be based on the milestone amount minus the match?

Response: Match will not be taken out of the disbursement, but rather monitored at each milestone and reporting instance, at which time a subgrantee will be asked to [report on match expenditure](#). ConnectMT will monitor to ensure allowability and allocability of match along with proportional expenditure.

5.22. Even though we're on a milestone disbursement, if we get audited, will expenses incurred prior to Grant Agreement execution be allowed? Ex: Expenses incurred via working with EHP consultants to start EHP review.

Response: Yes, limited pre-award expenses may be allowable and auditable if they meet BEAD and federal cost allowability standards. Pre-award expenses must be incurred after the publication of the BEAD NOFO and prior to Grant Agreement execution. They must be allowable, allocable, and reasonable under 2 CFR Part 200, and cannot exceed 5% of the requested BEAD funding. Allowable pre-award expenses include application development, early design engineering, and environmental and historical preservation (EHP) activities, such as hiring consultants to begin NEPA review. Construction activities and material procurement done before Grant Agreement signing are not eligible expenses. Subgrantees must keep enough documentation showing that any pre-award expenses are within the allowable category, time frame, and cost limit.

5.23. If a subgrantee is already using a Euna Grants account for an award in another state, will the ConnectMT award appear in the same portal?

Response: Subgrantees cannot login to the ConnectMT Euna Grants portal using the login information for another state. Subgrantees must create a new Euna Grants account or use an existing account that is used for other Montana grant programs. The ConnectMT Euna Grants portal is hosted on its own instance at mt.amplifund.com.

5.24. What should subgrantees do after receiving access to Euna Grants?

Response: After receiving the Award Activation email to access Euna Grants for BEAD, subgrantees should confirm their user roles and permissions. Any changes to the Authorized Organizational Representative should be relayed to ConnectMT. A [Euna Grants overview recipient training](#) is posted on the ConnectMT website for subgrantees to review.

5.25. What is the difference between “created” and “retained” jobs as required as part of reporting for BEAD?

Response: Created jobs are positions established as a direct result of BEAD funding that did not exist before the project started. Retained jobs are pre-existing positions that are kept or stabilized because of BEAD funding.

5.26. What constitutes a location being “connected”?

Response: The Restructuring Policy Notice defines standard installation as the initiation by a provider of fixed broadband internet access service within 10 business days of a request, with no charges or delays attributable to the extension of the network of the provider.

5.27. What level of documentation is required to justify grant and match expenditures?

Response: For reporting, only the total expenditure amount is required. However, subgrantees must maintain detailed supporting documentation for all costs within the project grant file. In accordance with NTIA BEAD requirements and 2 CFR Part 200, documentation must support that costs are allowable, allocable, and reasonable, and must be retained and made available upon request. Supporting materials may be reviewed during monitoring or audit activities.

5.28. What documents should subgrantees upload to the Quarterly Report if there have been no addresses served at the time of reporting?

Response: If no BEAD-funded locations were constructed and made serviceable during the reporting period, the SAR Served BSLs template may be uploaded as a blank template.

5.29. If a subgrantee has not received any orders from vendors, is there any obligation to upload BABA certification letters from manufacturers to the Quarterly Report?

Response: No. If no covered materials or equipment were ordered or received during the reporting period, there would be no manufacturer certification letters available to upload. The BABA attestation should still be completed for the reporting period as required.

5.30. When the Quarterly Report asks subgrantees for cumulative matching funds expenditures in QR3.6, is this calculation based on submitted milestones, disbursed milestones or based on actual expenditures for the reporting period?

Response: This calculation should be based on actual matching fund expenditures incurred by the project and not on submitted milestones, approved milestones, disbursements, or reimbursements. Expenditures should reflect actual costs incurred to date.

5.31. How should subgrantees handle the Quarterly Reporting question related to personnel employed under a consulting arrangement where they are performing milestone-related services?

Response: At this time, ConnectMT is not aware of specific NTIA guidance addressing consultants or contractors for this question. ConnectMT does not expect subgrantees to independently track all employment impacts across contractors and subcontractors. However, if documentation is available regarding jobs created or retained through consulting or contracted services, subgrantees are encouraged to report the information they are reasonably able to substantiate.

5.32. When the Quarterly Report asks subgrantees for the percentage of work completed in QR3.14, is this calculated by actual expenditures for the reporting period divided by total project cost?

Response: This field should reflect the estimated percentage of total project work completed as of the reporting date. The estimate should be based on overall project progress rather than a calculation of reporting-period expenditures divided by total project cost.

5.33. On the Evidence of Match Template Summary for the Quarterly Report, do subgrantees only need to enter the value in cell B16 – BEAD Portion (\$) Summary?

Response: Yes, the only manually entered field in the Totals section of the Summary tab is Cell B16 – BEAD Portion (\$) Summary. ConnectMT expects that Cell B16 reflects the BEAD-funded portion associated with the milestone request for which the template is being submitted, rather than the total award amount.

5.34. How do we complete the Eligible Use Percentage Allocation Template?

Response: The Eligible Use Percentage Allocation Template should be completed using the total BEAD funds awarded, rather than the total project cost (Cell C6). In Column D, the BEAD-funded portion of the project budget should be further allocated across the applicable eligible expense categories. The percentages in Column C will automatically populate based on the amounts entered in Column D. If the template is completed correctly, Cell B7 will display “Matched” and be highlighted in green.

5.35. Are there follow-up activities after Quarterly Report submission?

Response: Yes. Quarterly monitoring calls will be held after each reporting cycle to review progress and discuss any issues or updates. ConnectMT will reach out to subgrantees to schedule the quarterly monitoring calls, and a meeting agenda will be provided in advance of the call.

6. ENVIRONMENTAL AND HISTORICAL PRESERVATION

6.1. What are the Environmental and Historical Preservation Requirements under the BEAD Program? Were these requirements affected due to the Restructuring Policy Notice released by NTIA in June 2025?

Response: The BEAD Program and its participants must comply with Environmental and Historical Preservation Requirements set by NTIA. Eligible Entities and awardees are still responsible for obtaining all necessary federal, state, and local governmental permits on the environment. The RPN did not alter any Environmental or Historical Preservation Requirements for awardees.

6.2. In addition to the National Environmental Policy Act (NEPA), Montana has the Montana Environmental Policy Act (MEPA). Which law takes precedence?

Response: Applicants must adhere to NEPA first, and MEPA second, as federal statutes supersede state law. To view the most updated guidance from NTIA regarding NEPA, visit NTIA’s website [NEPA Resources page](#).

6.3. Are LEO satellite providers subject to the same NEPA and NHPA BEAD requirements as terrestrial internet providers?

Response: Due to LEO satellite providers not funding a defined portion of the transmission work in the same way that land-based systems are funded, LEO satellite providers can possibly be exempt from NEPA requirements. These providers must provide documentation to NTIA, which will identify excluded satellite projects within the program. 6.4. Are environmental studies and permit costs eligible pre-award costs?

Response: These “pre-award costs” would be allowable. The provider must follow NTIA’s defined process for NEPA. Additional information related to allowable and ineligible pre-award costs can be found on page 5 of the [NEPA for BEAD resource](#) and starting on pg. 5 of the [Connect MT Benefit of the Bargain Program Guide](#). If a provider has specific activities in mind, they are encouraged to email ConnectMT directly, and we can help validate if those activities would be considered allowable.

6.5. Can we start construction as soon as our Grant Agreement is executed or do we need additional approvals first?

Response: NTIA requires that all projects complete NEPA review and NEPA approval before any construction or ground disturbance activities can begin.

6.6. Will most fiber builds qualify for Categorical Exclusion (CATEX)?

Response: Many fiber projects typically qualify, but CATEX is not guaranteed. NTIA/ConnectMT must issue the determination, which can only be done via the EHP process.

6.7. Is NEPA approval needed before non-ground disturbing activities, such as ordering materials or mounting equipment to existing towers?

Response: NEPA approval is not required to proceed with non-ground-disturbing activities. Reasonable, permissible non-construction activities include completing studies, surveys, and other reviews necessary to apply for environmental permits or preliminary procurement, such as the purchase or lease of equipment (see [BEAD Terms and Conditions 13.E](#) for the complete list of permissible pre-implementation environmental and historic preservation activities)

6.8. For any maps that are submitted, should they be a PDF or uploaded in a shapefile format?

Response: Shapefiles are preferred, but PDFs are allowed. When submitting shapefiles to Euna Grants, they must be converted into zipped files.

6.9. In addition to a Cultural-Historic Preservation review requiring a Certified Professional. What other tasks require a Certified Professional?

Response: It is recommended to utilize certified professionals throughout the entire EHP process, when possible.

6.10. What is the required certification that an individual needs? For example, is there a Secretary of the Interior (SOI) “test” one must take, or do they have to have qualifications under SOI Guidelines?

Response: The Secretary of the Interior (SOI) Professional Qualifications Standards are federally recognized minimum education and experience requirements for professionals required to carry out various Environmental and Historic Preservation (EHP) activities. The BEAD EHP process must be completed to ConnectMT’s and NTIA’s satisfaction prior to any deployment activities. Therefore, subgrantees are strongly encouraged to retain the services of an experienced and appropriately credentialed (aka SOI Qualified) professional with expertise in environmental compliance and impact analysis, and in the planning, research, and review of historic properties and cultural resources. See [The Secretary of the Interior Professional Qualifications Standards | U.S. Department of the Interior](#) for more details.

6.11. If we are ready to ask Montana SHPO for a letter, who should we contact?

Response: Pete Brown, Program Manager/State Historic Preservation Officer at the State Historic Preservation Office (pebrown@mt.gov).

6.12. What are the expectations for ground-level and aerial photos submitted with project routes?

Response: Ground-level photos must show actual existing conditions along the route, at the locations where work will occur — right-of-way, existing poles or conduit, road shoulders, vegetation, adjacent structures, and visible resources like water crossings or older buildings — so reviewers can assess potential impacts. ConnectMT will want current photos of actual field conditions; best practice is geotagged, date-stamped field photos. Aerial photos must provide an overhead view, placing the route in context — land use, proximity to water features, floodplains, parks, conservation areas, and developed vs. undeveloped land. Google Earth may not reflect present conditions and is generally not sufficient on its own. ConnectMT recommends pairing aerial maps with corresponding ground-level photos for each route segment. Ground-level photos should be clearly referenced to specific locations on the aerial map (e.g., numbered points) so reviewers can correlate each image to the route. This combined approach supports a more efficient and complete EHP review.

7. BEAD AWARD COMPLIANCE

7.1. If an applicant submits an application comprised solely of a high-cost Census Block Group (CBG) that is exempt from the match requirements, is a Letter of Credit still required?

Response: Yes, a Letter of Credit is a required component of all applications.

7.2. Are assets purchased under this program subject to federal interest?

Response: Yes. The Federal Interest Period as defined in the draft Grant Agreement will last until December 31st of the 10th year after the acceptance of the Closeout Report by the Department of Commerce (DOC) and NTIA. If awarded a grant, please review the final Grant Agreement as this requirement may change. The State will determine if there will be additional filing and reporting requirements with regards to the Federal Interest at a later date. See the draft [Grant Agreement](#) and its [Exhibits](#) posted on the ConnectMT website.

7.3. Can you confirm the number of years that post-completion reporting will be required?

Response: Subgrantees must report for four to ten years after receiving a subgrant, depending on the technology type, and through 120 days prior to the end of the MT BEAD period of performance. After this date, any additional reporting requirements will be based on the technology type identified in the application, pursuant to 2 C.F.R. 200.344.

7.4. Does BABA apply to all BEAD projects, including BEAD LEO projects?

Response: Yes, [BABA](#) applies to all BEAD projects. BABA applies to infrastructure projects, including deployment of broadband networks, and “infrastructure projects” are defined as any activity related to the construction, alteration, maintenance, or repair of infrastructure in the United States regardless of whether infrastructure is the primary purpose of the project (See 2 CFR § 184.3). To the extent that placing radios into a LEO system includes “any activity related to the construction, alteration, maintenance, or repair of infrastructure,” the components used in that construction/alteration would be subject to BABA, even if the electronics were waived.

7.5. Do sub-awardees have to comply with Davis-Bacon? If not, what regulations must the sub-awardee adhere to?

Response: Sub-awardees are no longer required by the BEAD Program to adhere to the Davis-Bacon federal statute. A sub-awardee can comply with Davis Bacon statute if they wish. If a sub-awardee does not wish to adhere to the Davis-Bacon statute, they must provide a project employment and local impact report detailing the number of contractors, employees on the project, wages and benefits of workers, and whether those wages are less than those prevailing. 7.6. How long will subgrantees have to complete construction?

Response: Subgrantees will have 4 years from the date the agreement with the State is fully executed to complete construction.

7.7. When are Grant Agreements required to be signed and returned to ConnectMT?

Response: Grant Agreements must be signed and returned to ConnectMT via Docusign by May 31st, 2026. Awardees must also provide the following documents: Official Tribal Consent (if applicable), Official ILOC from a financial institution (if applicable).

7.8. What is the order of operations for Subgrantees to receive their subgrant agreement from the ConnectMT and begin the subgrant period of performance, and to have funds made available?

Response: All subgrant agreements must be signed by May 31st, 2026. The period of performance for the subaward will begin once the subgrant agreement is signed by both parties (ConnectMT and the Subgrantee), in accordance with the terms and conditions of the subgrant agreement. ConnectMT may not release funding to Subgrantees until the “BEAD Program Default Certificate” certification (Exhibit E) is signed and submitted to ConnectMT, along with their signed subgrant agreement and supplemental required materials (if applicable), i.e., Tribal Consent and/or ILOC. Note that ConnectMT may still be required to hold back grant funding until certain activities have been completed (e.g., NEPA requirements).

7.9. What should we do immediately after receiving our Grant Agreement?

Response: ConnectMT recommends setting up your internal grant file, confirming your Authorized Organizational Representative (AOR), and beginning to assemble post-award documentation, such as any required tribal documentation. Organizations should also review program documents such as the [Disbursement Process Guide](#), Monitoring Guide, [EHP guide](#), and the [BEAD NOFO](#) and [Terms and Conditions](#).

7.10. What records must the subgrantee retain and for how long?

Response: Subgrantees shall create and retain all records, including all receipts, disbursements, and other transactions, supporting the Grant Agreement, for a period of 7 years from the date the ConnectMT notifies the Subgrantee that the final required BEAD report has been submitted.

7.11. What BABA documentation should subgrantees keep on file?

Response: Subgrantees should maintain supplier/manufacture certifications identifying the applicable BABA category and confirming domestic production (and domestic content thresholds for manufactured products), plus procurement language flowing requirements to contractors, and any waiver documentation/approvals.

7.12. What corrective actions may be required if non-compliance is identified?

Response: If ConnectMT identifies instances of non-compliance through reporting, monitoring, audits, or other oversight activities, the subgrantee may be required to implement corrective actions to address the issue. Corrective actions may include, but are not limited to, submitting additional documentation, implementing enhanced monitoring, or taking other remedial steps as outlined by ConnectMT. Continued or unresolved non-compliance may result in additional enforcement actions consistent with the BEAD Grant Agreement, including potential delays in disbursement or other remedies permitted under federal and state requirements.

7.13. When can a subgrantee request a change to the approved project scope?

Response: Subgrantees may request a change to the approved project scope when circumstances arise that affect the originally approved project, including changes to project design, service locations, technology, schedule, or implementation approach. All proposed changes must be reviewed by ConnectMT and submitted to NTIA for approval prior to implementation.

7.14. What types of project changes are considered a “scope change” under the BEAD Program?

Response: A scope change includes any modification that alters key components to the approved project. This may include changes to the number or type of Broadband Serviceable Locations (BSLs), project boundaries, technology type, deployment approach, or subgrantee structure. Project changes require prior approval when they materially alter the approved project or exceed NTIA-defined thresholds.

8. NON-DEPLOYMENT FUNDS

8.1. Has ConnectMT or the CAC addressed the issue of issuing a portion of BEAD funds or other federal broadband funds to help utilities cover their increased locating costs associated with broadband deployment construction projects?

Response: Co-location costs are considered allowable expenses for BEAD; however, these costs must be recognized by the awardee. We recommend engaging in discussions with ISPs to gain a clearer understanding of awarded BEAD projects.

ConnectMT is still awaiting guidance from NTIA regarding the eligible uses of non-deployment funds.

8.2. How will ConnectMT communicate new guidance related to the use of non-deployment funds?

Response: ConnectMT will communicate any new guidance related to the use of non-deployment funds through official program communications, including updates to the ConnectMT website. When applicable, ConnectMT may also address new guidance during a technical assistance webinar or office hours. Subgrantees are encouraged to regularly review communications and program resources to stay informed of updates.

9. CLOSEOUT & POST-COMPLETION OBLIGATIONS

9.1. What can my organization expect from the Closeout Report?

Response: Subgrantees will submit a final closeout report in Euna Grants no later than 15 days after the completion of the project. The report and required documentation is expected to include final buildout map, subscriber location list, final disbursement request, performance testing data, and final project as-built documentation. ConnectMT will confirm the closeout criteria before submission to align with current NTIA guidance and audit requirements.

9.2. What performance testing should subgrantees plan for at project closeout?

Response: At closeout, subgrantees will provide a list of active subscribers to ConnectMT through the Euna Grants system. This list will contain all locations within the project area that are currently connected and receiving service. ConnectMT will select at least 10 of those locations for testing. Subgrantees are strongly encouraged to refer to the BEAD Monitoring Guide for more detailed information regarding performance testing.
